**NEW WITH PAPPG 19-1:** Biggest changes to proposal preparation guidance are as follows:

1. **Resubmissions has been revised to establish that NSF programs that accept proposals at any time may have guidelines in which a declined proposal is ineligible for resubmission for a specified period of time.**
2. The Project Description should now include a description of work to be performed by any sub-awards.
3. Bio-sketch - Synergistic Activities section has been revised to specify that a list should include up to 5 distinct examples that demonstrate the broader impact of the individual’s professional and scholarly activities that focuses on the integration and transfer of knowledge as well as its creation.
